ADMINISTRATOR/SPONSOR:

This Contest is administered by Family Holiday Traditions, LLC ("Administrator). The Contest will be conducted under the supervision of Administrator. The decisions of Administrator are final and binding on all matters relating to the Contest.

1) Eligibility:

Sweepstakes open to legal residents of all Fifty (50) United States, who are at least eighteen (18) years of age at the time of entry with some restrictions. This offer is subject to and is void wherever prohibited or restricted by national, state, municipal, provincial or any other government laws, and is not offered in states where registration of this Sweepstakes is required.
